-Notification of Japan concerning differnces between national practices and Standards of the FAL Convention-(with regard to 2016 amendments of the Annex)

STANDARDS

2.1	Due to the enforcement of the Ordinance for the Act on Regulation of Fishing Operation by Foreign Nationals (February 4, 2017), the Japanes authorities require the following documents which are not stipulated in this Standard. Notification of pre-arrival of foreign fishing vessels Notification of pre-departure of foreign fishing vessels Tapan has already notified the differences to this Standard. The above-mentioned notification is to be added to the existing list.) Besides, Japan withdraws the following, which it previously notified, from the notification of the difference to this Standard. Arrival notice (to the Immigration Authority)	
2.8.1	In Dangerous Goods Manifest, the Japanese authorities require "master's name", which is not stipulated in this Standard.	
2.24	In General Declaration (notice of arrival and departure), the Japanese authorities require "position of the ship in the port", which is not stipulated in the Recommended practice 2.2.2.	
3.44bis	The Immigration Authorities of Japan do not communicate reasons for shore leave denial to the seafarer concerned in writing.
