SUMMARY REPORTS AND ANALYSIS OF MANDATORY REPORTS UNDER MARPOL FOR THE PERIOD 2010 – 2015

- The Marine Environment Protection Committee (MEPC), at its sixty-seventh session (13 to 17 October 2014) endorsed a request of the Sub-Committee on Implementation of IMO Instruments (III), at its first session, to issue an annual circular on mandatory reports under MARPOL covering parts 1a, 1b, 2 and 4 of the formats for a mandatory reporting system under MARPOL (MEPC/Circ.318). The first annual circular was issued as MEPC.1/Circ.852 covering the period 2008 2013 and followed by MEPC.1/Circ.860 for the period 2009-2014.
- The current circular is based on mandatory reports for the year 2015 submitted by Parties to MARPOL and updated for the period 2010 to 2015, using the revised reporting formats for a mandatory reporting system under MARPOL set out in MEPC/Circ.318, aimed at facilitating communication to the Organization of information called for by articles 8, 11 and 12, regulation 12 of Annex I, regulation 7 of Annex II and regulation 8 of Annex V of MARPOL. The data from these reports will be useful to the Organization to assess the effectiveness of the application of the Convention and for statistical purposes.
- Parties to MARPOL are requested to submit their annual reports, using the reporting format set out in MEPC/Circ.318, to the Secretariat by 31 December each year. Nil returns are required from Parties for each reporting requirement from the perspective of port, coastal or flag States. Mandatory reports under MARPOL, as well as any queries on the management of the data contained in the annual circular, should be submitted to the Secretariat by post or email to:

A Notwithstanding the above, Parties to MARPOL are urged to provide and/or update their respective contact details in the Port Reception Facilities module of GISIS to ensure notification of port States by flag States reporting on alleged inadequacies in accordance with the procedures set out in the *Consolidated guidance for port reception facilities providers and users* (MEPC.1/Circ.834).

ANNEX

ANALYSIS AND EVALUATION OF MANDATORY REPORTS UNDER MARPOL FOR 2010 to 2015

- The status of mandatory reports under MARPOL from 2010 to 2015 is set out in appendix 1. It shows which Parties submitted reports in the last five years and which Parties failed to do so, as well as, the additional information requested by the Sub-Committee on Implementation of IMO Instruments (III) for identifying Parties who have submitted reports outside of the reporting periods.
- In 2016, the Secretariat received mandatory reports under MARPOL, in accordance with MEPC/Circ.318, for 2015 from 38 Parties and one Associate Member. Amendments to the last annual circular (MEPC.1/Circ.860) received from Parties were incorporated in the present circular. Parties are invited to note the following points:
 - .1 part 1(a) of MEPC/Circ.318: five Parties (out of 38 actually reporting) (Italy, Liberia, Norway, Singapore and Spain) reported eight incidents of spillage of 50 tonnes or more. The type of spillage was mostly fuel oil but there were two spillage incidents involving Annex II materials;
 - .2 part 1(b) of MEPC/Circ.318: 18 Parties (out of 38 actually reporting) (Argentina, Australia, Bahamas, Denmark, Islamic Republic of Iran, Israel, Italy, Kazakhstan, Latvia, Liberia, New Zealand, Norway, Panama, Philippines, Poland, Romania, South Africa and Sweden) reported 288 incidents of spillage of less than 50 tonnes in 2015, involving 46 Parties. The types of substances spilled were mostly various hydrocarbon oils, representing 86.11% of the total incidents (total of 288 incidents). Seven Parties reported a total of 15 incidents involving Annexes IV and V materials, constituting 5.21% of overall incidents. Seven Parties reported substances other than oil, such as synthetic drilling mud, drilling fluids, chemicals, paints and vegetable oils. Overall, spillage of non-oil substances constituted about 8.68% of reported incidents under part 1(b);
 - .3 part 2 of MEPC/Circ.318: eight Parties (out of 38 actually reporting) (France, Germany, Italy, Japan, Netherlands, Romania, South Africa and Spain) reported 28 incidents on alleged discharge violations in 2015. The types of substances discharged were various types of fuel oils and lubricant/hydraulic oils and also included garbage, vegetable oil, sulphur and tank washings;
 - part 4, sections 1 and 2 of MEPC/Circ.318: the total number of ships boarded in 2015 by port State control of the 38 Parties reporting the outcome of inspections was 44,301, while the total number of ships detained in port or denied entry was 362, which represents 0.82% of those boarded (see appendix 2):
 - .5 part 4, section 1 of MEPC/Circ.318: of the 44,301 reported boardings; 17 ships had no IOPP Certificate or equivalency, 263 ships had discrepancies in their IOPP Certificate or equivalency; 1,064 ships had oil record book or equivalency discrepancies, 22 ships had no oil record book or equivalency; 117 ships lacked required pollution prevention equipment and 1,557 ships had required equipment that was not functioning. In total, 3,040 discrepancies were recorded in 2015 (see appendix 2);

part 4, section 3(a) of MEPC/Circ.318: on penalties imposed by port States; the number and amounts of penalties imposed by 13 Party port States that reported (Argentina, Australia, Azerbaijan, China, Georgia, Germany, Israel, Italy, Japan, Latvia, Poland, Romania and Spain) are shown in table 1. Twenty-five Party port States had no information on imposed penalty for all types of violation; and

Compliance with the provisions of MEPC/Circ.318

- Compliance reporting in accordance with MEPC/Circ.318 continues to be relatively low. For the 2015 reporting year, 38 Parties submitted their reports before the deadline (31 December 2015). While the total number of Parties increased from 152 to 153 with the accession of Sudan in 2015, this increase is not in effect for the 2015 reporting period. Hence, compliance reporting statistics are adjusted based only on submitted reports, including data of previous reporting years.




Figure 1: Reporting rates in compliance with the provisions of MEPC/Circ.318

- Of the 38 Parties reporting for 2015, 21 Parties have consistently submitted their reports annually since 2009 and two Parties have submitted reports which covered previous years. Across the reporting years from 2010 to 2015, 22 Parties have not been consistent with their reporting; in some instances there is a gap of one or more years before a report is again submitted. Hence, the pattern of submission by those 23 Parties have caused the level of reporting to fluctuate from 38 to 43 across the reporting years from 2010 to 2015. No report was submitted by 91 Parties since 2009. Figure 1 shows the compliance reporting pattern on a yearly basis, adjusted from 2011 based on later submissions of reports that covered previous reporting periods from 2011 to 2014.

For 2015, 38 Parties reported, representing a compliance reporting rate of only 25% despite the moving of the deadline for reporting from September to 31 December 2015. About 59.9% of the total of Parties to MARPOL have not submitted any reports since 2010.
