The new seafarers' book identity document is printed on appropriate paper, resistant to humidity, increasing its durability and conservation and in addition contain several /safety/security elements to hinder or even prevent its falsification. The same document will dignify the national seafarer's, and presents the characteristics required by the international instruments concerning the seafarers' identity document as used by the maritime administrations from other latitudes, with all data and information written in Portuguese and English issued through a modern and secure electronic platform.

The present identity document will assure to the Cabo-Verdean seafarers the facilitation to shore leave and transit and transfer in foreign ports or countries.

The new seafarers' identity document shall be promptly withdrawn by the Cabo Verde Maritime Administration if it is ascertained that the seafarer no longer meets the conditions for its issue, in strictly compliance of the international instruments.

The official launch of the new Seaman's Book was held on past June 25, as part of the International Maritime Day celebrations and the old Seaman's Book will be valid until December 31, 2021.
