## Communication of information from Denmark pursuant to Article 4 of the STCW Convention

In accordance with Article IV of the STCW Convention as amended the Government of Denmark wish to inform that a new format to the STCW Certificates issued by the Danish Maritime Authority will be introduced from the 25 October 2021. The new certificates are issued in accordance to the regulations of the STCW Convention.

Attached is an example of the new format for the Danish STCW Certificates.

The new STCW Certificates includes the required information according to the relevant sections. On our <a href="https://verify.dma.dk/category">https://verify.dma.dk/category</a> the authenticity and validity of STCW-Certificates can be verified as required by regulation I/2 para- graph 15.

Danish STCW Certificates issued in accordance with the preceding format are not canceled nor revoked, as they are still valid until the date of expiry. Thus, there will be a transitional period for 5 years from the date of entry into force of the new STCW Certificates. In this period, there will be two valid types of designs to the Danish STCW Certificates. This is due to the validity period of a certificate being a maximum of 5 years. The authenticity and validity of both types Certificates can be verified as explained above.
